TERMS of the AGREEMENT:

- Acceptance into the Recreational Academy will not be confirmed until the deposit of \$300.00 or full payment is remitted with the child's registration. Deposit is due on April 30, 2025, or upon the signing of the contract if after April 30, 2025.

I acknowledge that \$150.00 of the initial deposit is NON-REFUNDABLE after May 30, 2025. _____ (Initial)

- Payment must be made by the due dates given unless alternative arrangements are made with school administration. *Payments not made in the timeframe arranged may result in the child being suspended from the program and any programming items (i.e., clothing, equipment, etc.) may be withheld until payment is met.* If any circumstances which may change the ability to meet the payment requirements, families are responsible for contacting the school to make alternative arrangements as soon as possible.

I acknowledge that all payments are due when specified and should I default in meeting any payments, my child's participation in the program may be suspended until payment is made. _____ (Initial)

- Should the child temporarily be suspended from the academy and/or the school, or should the child be unable to attend some of the programming, fees will not be refunded unless the child is withdrawing permanently from the recreation academy within the 2025-2026 school year. Funds will be reimbursed on a per-month basis only, with the last day of the month used for calculation purposes.

I acknowledge that refunds will only be given if my child withdraws from the program permanently during the 2025-2026 school year. _____ (Initial)

- All students in the recreation academy are expected to attend all trips planned by the Recreation Academy teacher. Students who wish not to participate or are unable to participate in certain activities will travel with the group and be a spectator for the duration of the activity.
